## Sovereignty Station Application

We acknowledge that PCCOH is currently building a statewide Citizens network to give Ohioans a voice for holding the government accountable to our Constitution. Their goal is to create a network of patriotic Citizens 1,000,000 people strong. The purpose of this project is to unite the people of Ohio for protecting our individual rights and liberties from governmental encroachments.

Additionally, PCCOH is introducing a proposed **Sovereignty Amendment to the Ohio Constitution** to be placed on the ballot in November 2010. This amendment is designed to establish, in express terms, the sovereignty of the people over their governments, setting forth explicit duties to protect Ohioans from governmental abuse and defined limits for governmental powers.

We wish to volunteer as an official SOVEREIGNTY STATION for PCCOH and post a sign in our business giving notice to the people that they can enter to review and sign the petition for the proposed Ohio Sovereignty Amendment. We understand that our business will be listed on the PCCOH website to notify people that they can sign the petition at our location.

## *Sovereignty Station Instructions*

To help PCCOH track the signature collection process, the following procedures must be followed:

1. Display the SOVEREIGNTY STATION signs you receive in a prominent place where they can be easily seen by people passing or entering your business.
2. Report to PCCOH each Monday the total number of petition signatures currently in your possession directly to PCCOH at [Rick@pccoh.com](mailto:Rick@pccoh.com). Present your report similar to the following format. Example: "Sta. No. 29-153 with 42 signatures"
3. Each designated "Circulator" (petition witness) must use their own petitions when collection signatures. Each Circulator should specify on the SOVEREIGNTY STATION APPLICATION what hours they will be available for people to appear and sign their petition. We recommend no more than two Circulators per Sovereignty Station.
4. Follow the petition Instructions PRECISELY when collecting signatures. These instructions are attached as the first page on each petition packet and available for download at [www.pccoh.com](http://www.pccoh.com). Failure to adhere to the instructions will result in disqualification of the signatures.
5. As petitions become full, or as instructed by PCCOH, please send the completed petitions to the location specified on the petition Instructions page.
6. Attempt to pre-qualify all petition signatories prior to them signing the petition by asking them relevant questions. Basic qualifications for an elector are provided at the bottom of the last page of the petition.
7. If you have any questions pertaining to the petition, our cause, or any other matter pertaining to PCCOH, either search our website or contact the committee at [committee@pccoh.com](mailto:committee@pccoh.com).
8. In the event you choose to discontinue your support for PCCOH, please contact us so that we can adjust our records accordingly.
